Dear Sir/Madam,

I refer to the above scheme and, as directed by Chief Executive Order Numbers CE61772, dated 2nd October 2025 and CE 62335, dated 15<sup>th</sup> October 2025, I hereby submit the documents listed below and request the confirmation of An Coimisiún Pleanála for the Compulsory Purchase Order, to enable the implementation of this road scheme as a matter of priority.

The scheme comprises the compulsory acquisition of lands and the construction of the following: Approximately 2.0 km of mainline single carriageway; Approximately 0.15 km of realigned R405 Regional Road; 1 major bridge crossing of the river Liffey approximately 75 m long; Utility diversions; Drainage system, including attenuated outfalls and Landscaping and environmental mitigation measures; together with all ancillary and consequential scheme works.
