COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF, AND THE THIRD SCHEDULE TO, THE HOUSING ACT, 1966, AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960 (SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT, 1966) AND AMENDED AND EXTENDED BY THE PLANNING AND DEVELOPMENT ACTS, 2000 – 2022. THE LOCAL GOVERNMENT (No. 2) ACT, 1960, THE ROAD ACTS, 1993 – 2023. (I)	All rights, including but not limited to any fishing or navigation rights, existing over that section of the River Liffey partly traversing the Townlands of Celbridge Abbey in the District Electoral division of Celbridge and Donaghcumper and the County of Kildare and between the green lines AC1 and AC2 , running for a distance of approximately 130.00 metres and shown on Drawing No. MDT0902-RPS-00-XX-DR-Z-DP0001 of the Deposited Maps.

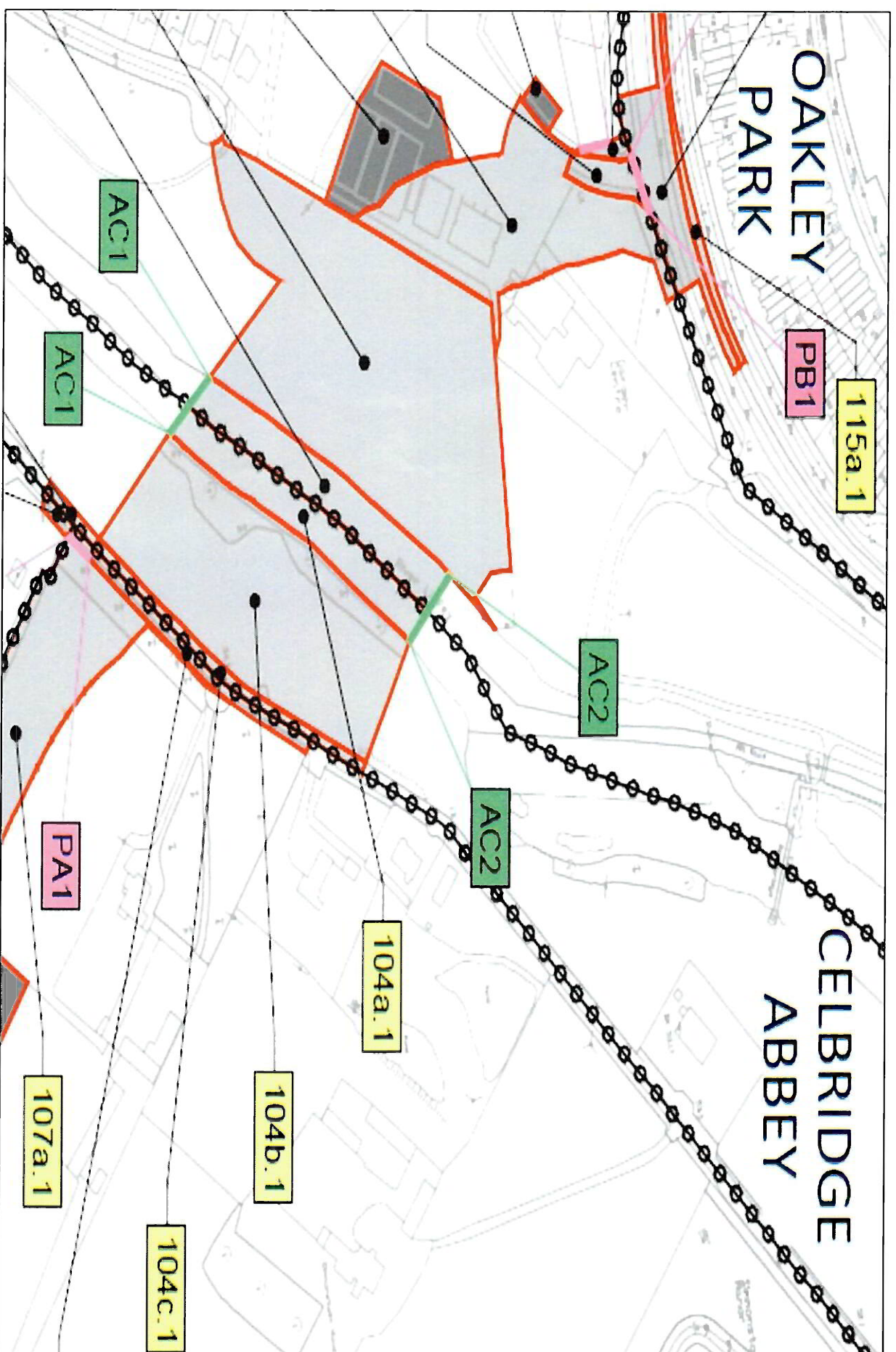
