FÓGRA MAIDIR LE hATHRÚ BEARTAITHE UIMH. 3 AR PHEAN FORBARTHA CHONTAE CHILL DARA 2023- 2029 (ARNA ATHRÚ) CHUN FEIDHM A THABHAIRT DO THREOIRLINTE AN AIRE A FOILSÍODH DE RÉIR ALT 28 DEN ACHT UM PLEANÁIL AGUS FORBAIRT 2000 (ARNA LEASÚ)

Tugtar fógra leis seo, de bhun Alt 13 (2)(b) den Acht um Pleanáil agus Forbairt 2000 (arna leasú), go bhfuil Comhairle Contae Chill Dara ag moladh athrú a dhéanamh ar Plean Forbartha Chontae Chill Dara 2023 – 2029 (arna athrú) (dá ngairtear 'an Plean' feasta). Cuirfear an tAthrú Beartaithe san áireamh sa Ráiteas Scríofa (Imleabhar 1) den Plean.

Cúis le hAthrú Beartaithe Uimh. 3

Ullmháidh an tAthrú seo chun an Plean a ailíniú le Treoirilnte Aireachta a foilsíodh de réir Alt 28 den Acht um Pleanáil agus Forbairt 2000 (arna leasú). Is iad na treoirilnte ábhartha ná:

1. Cur i bhFeidhm NPF: Treoirilnte maidir le Riachtanais Fáis Tithíochta d'Údarás Pheanála (2025), a foilsíodh chun éifeacht a thabhairt don Chéad Athbheithniú ar an gCreat Náisiúnta Pleanála (2025), agus
2. Treoirilnte um Fhorbairt Chónaithe Inbhuanaithe agus Lonnaíochtaí Dlútha d'Údarás Pheanála (2024).

- Athbheithniú ar raonta agus critéir dlúis chónaithe le haghaidh forbairtí cónaithe nua, chun go mbeidh siad ar aon dul leis na Treoirilnte um Fhorbairt Chónaithe Inbhuanaithe agus Lonnaíochtaí Dlútha d'Údarás Pheanála (2024).

NOTICE OF PROPOSED VARIATION NO. 3 OF THE KILDARE COUNTY DEVELOPMENT PLAN 2023-2029 (AS VARIED) TO GIVE EFFECT TO MINISTERIAL GUIDELINES PUBLISHED IN ACCORDANCE WITH SECTION 28 OF THE PLANNING AND DEVELOPMENT ACT 2000 (AS AMENDED)

Notice is hereby given pursuant to Section 13 (2)(b) of the Planning and Development Act 2000 (as amended), that Kildare County Council proposes a variation to the Kildare County Development Plan 2023 – 2029 (as varied) (hereafter referred to as 'the Plan'). The Proposed Variation will be incorporated into the Written Statement (Volume 1) of the Plan.

Reason for Proposed Variation No. 3

This Variation has been prepared to align the Plan with Ministerial Guidelines published in accordance with Section 28 of the Planning and Development Act 2000 (as amended). The relevant guidelines are:

1. NPF Implementation: Housing Growth Requirements Guidelines for Planning Authorities (2025), which were published to give effect to the National Planning Framework First Revision (2025).
2. Sustainable Residential Development and Compact Settlements Guidelines for Planning Authorities (2024).

Content of Proposed Variation No. 3

This Variation comprises of amendments to; Chapter 1 Introduction and Strategic Context, Chapter 2 Core Strategy and Settlement Strategy, Chapter 3 Housing, and Chapter 15 Development Management Standards of the Written Statement (Volume 1) of the Plan to include the following overarching policy amendments:

- An increase in County Kildare's housing growth requirement for the remaining 3 years of the Plan, to align with the NPF Implementation: Housing Growth Requirements Guidelines for Planning Authorities (2025).
- Revised residential density ranges and criteria for new residential developments, to align with the Sustainable Residential Development and Compact Settlements Guidelines for Planning Authorities (2024).

The Proposed Variation is accompanied by:

- A Settlement and Site Capacity Audit.
- An Appropriate Assessment (AA) Screening Report pursuant to the EU Habitats Directive (92/43/EEC).
- A Strategic Environmental Assessment (SEA) Screening Report pursuant to the Planning and Development (Strategic Environmental Assessment) Regulations 2004 – 2011.
