1. Introduction to the County Kildare Draft Heritage Plan 2026-2031

This draft heritage plan sets out a range of actions to protect and enhance the heritage of county Kildare for the next five years (2026-2031). The draft plan is a result of the work undertaken primarily by the County Kildare Heritage Forum. a partnership committee set up by Kildare County Council, in consultation with the local community and local, regional and national organisations with an interest in and remit for the heritage of County Kildare. This work is facilitated by the Council's Heritage Officer and staff from the Heritage and Nature Team. County Kildare Heritage Forum is comprised of elected representatives, council officials and representatives from state agencies, local heritage and community groups and the farming, education and business sectors.

Following a pre-draft public consultation process held in June 2025, submissions were received from the public on a range of heritage issues. The Heritage Forum looked at each submission and assessed it for possible inclusion as an action or set of actions in the plan. The Forum also assessed the strategic objectives and actions in the current (2019-2025) Heritage Plan. These two strands were then combined into the strategic objectives and actions in this draft plan.

The next phase in developing the new Heritage Plan is to ask the people of Kildare to have their say. Public engagement is a cornerstone of a successful Heritage Plan. Much of the heritage of the county is in the care of groups and individuals – from voluntary committees maintaining historic graveyards to the different biodiversity-focussed groups protecting bats, birds and wider habitats, as well as local history groups and those maintaining old craft traditions in the county. All will be interested to see that their goals and aspirations are reflected in this plan. The public consultation

process will seek to engage as widely as possible across the county in order to gather the broadest range of views and suggestions possible. All submissions received will be assessed by the Heritage Forum and a final Heritage Plan will be presented to the elected members of Kildare County Council for adoption at the end of this year following this process. This process will result in a plan that will help to shape the way we record, protect and explain our built, cultural and natural heritage over the next five years.

2. Policy Context

The following are the main strategic policy documents that have influenced the preparation of the draft Heritage Plan.

2.1 National and Regional Policy

Project Ireland 2040- National Planning Framework (NPF): The NPF is a high-level strategic plan for shaping the future growth and development of the country to the year 2040. It is a framework to guide public and private investment, to create and promote opportunities, and to protect and enhance the environment. Within the NPF, Enhanced Amenities and Heritage has been identified as a National Strategic Outcome and has been identified as a Strategic Investment Priority. The framework was revised in 2025 to more directly address housing delivery and affordability challenges.

Regional Spatial and Economic Strategy (RSES) 2019-2031 - East and Midlands: A RSES is a strategic plan which identifies regional assets, opportunities and pressures and provides appropriate policy responses in the form of Regional Policy Objectives (RPO). A number of these in the draft RSES address built and natural and heritage issues.

Heritage Ireland 2030: Is Ireland's national Heritage Plan- it establishes a framework for the understanding and enjoyment of heritage for the next decade under three themes – "National

Leadership and Heritage", "Heritage Partnerships" and "Communities and Heritage". A series of objectives under each theme are detailed in the plan.

Heritage Ireland 2030 sets out a framework for action across government, local authorities, communities, and individuals. It promotes stronger leadership, better coordination, and more meaningful public engagement, while also supporting innovation, education, and sustainable development.

Culture 2025 & Creative Ireland: Culture 2025 - Éire Ildánach A Framework Policy to 2025 was published by the Department of Arts, Heritage, Regional, Rural and Gaeltacht Affairs in 2016. The aim of this policy is to put culture at the heart of our lives and develop a more collaborative approach across all sectors. This policy is underpinned by a commitment to increase resources for arts and heritage and to improve funding structures for investment in national and local services. Priorities include the identification of priority actions in the heritage area. The Culture 2025 policy is supported by the implementation vehicle, Creative Ireland Programme/ Clár Éire Ildánach 2017-2022 (extended to 2027), which commits to an increased investment in arts and heritage, the promotion of collaboration and the production of a Culture and Creativity Plan by the Culture Team in each local authority.

National Biodiversity Action Plan (NBAP) 2023-2030: Ireland's 4th National Biodiversity Action Plan sets out the national biodiversity agenda for 2023 - 2030, building on the progress made through previous plans. It outlines key objectives, targets, and actions for government, civil society, and the private sector to help achieve Ireland's Vision for Biodiversity. The plan takes a "whole of government, whole of society" approach and provides a framework to monitor progress across five strategic areas, including conservation, restoration, public engagement, and international cooperation. The proposed Heritage Plan will align closely with the NBAP, incorporating its priorities and contributing to the protection and enhancement of biodiversity in County Kildare.

All Ireland Pollinator Plan 2021-2025: This plan encourages landscape-level change to support biodiversity and provides practical, sector-specific guidelines that continue to inform and support this work in Kildare. This Heritage Plan will align with the Pollinator Plan's goals, incorporating its guidance to help protect pollinator species and promote biodiversity across the county. The associated sectoral guidelines produced through the Pollinator Plan provide a valuable resource to promote collaboration in Kildare and assist the implementation of related actions in the Kildare Heritage Plan 2026-2031.

Department of Culture Heritage and the Gaeltacht sectoral plans for Climate Change

Adaptation: The Department of Culture Heritage and the Gaeltacht are preparing Climate Change sectoral plans for climate change adaptation for Built and Archaeological Heritage and Biodiversity. These plans will contain climate change adaptation actions, for the benefit of heritage, to be implemented by local authorities and the general public.

A new plan for Built Archaeological Heritage and Climate Change is currently being finalised, replacing the previous 2019 version and reflecting updated risks, priorities, and stakeholder input.

Sustainable Development Goals, National Implementation Plan 2018 - 2020: In 2015, the United Nations adopted the 2030 Agenda for Sustainable Development and its 17 Sustainable Development Goals (SDGs).

Targets and measures for the protection of ecosystems, landscapes and cultural heritage have been set by the SDGs such as SDG Target 11.4, which is an overarching objective for heritage to: "Strengthen efforts to protect and safeguard the world's cultural and natural heritage". The Sustainable Development Goals National Implementation Plan 2018 - 2020 is in direct response to the 2030 Agenda for Sustainable Development and provides a whole-of-government approach to implement the 17 Sustainable Development Goals (SDGs).

Waters and Communities: The Local Authority Waters and Communities Offices (LAWCO) is a relatively new approach to public participation in the management of our natural waters and delivery of the Water Framework Directive. It recognises the value of local partnerships in the management of local rivers, lakes or coastal waters and offers advice on technical issues and funding opportunities for community projects. There is great potential for such projects to enhance the water quality, habitat value and recreational use of Kildare's water.

The National Peatlands Strategy 2015-2025: This strategy, prepared in consultation with the Peatlands Council and with relevant Government Departments, agencies and semi-State companies was published by the Department of Arts, Heritage and the Gaeltacht in 2015. The strategy arose from the need to take a broad strategic approach to the future management of Ireland's peatlands. This aims to provide a long-term framework within which all of the peatlands within the State can be managed responsibly in order to optimise their social, environmental and economic contribution to the well-being of this and future generations.

2.2 Local Policy

Kildare County Development Plan 2023-2029

The Kildare County Development Plan 2023-2029 (CDP) sets out the statutory framework for land use planning and sustainable development in County Kildare. The Heritage Plan sits within the policy framework of the CDP and aims to support and strengthen the role of the CDP and other land use plans by providing baseline information to inform policy for the protection, conservation, management and promotion of heritage.

Kildare Local Economic and Community Plan 2023-2029

The Kildare Local Economic and Community Plan (LECP) is a six-year plan prepared by the Local Community Development Committee (LCDC) in conjunction with Kildare County Council. It contains objectives and actions to promote and support economic, local and community development of County Kildare. The LECP will form the strategic framework for all publicly funded local, economic and community development programmes. Heritage makes a significant contribution to quality of life and well-being, and plays a role in strengthening of communities and contributes to the socio-economic development of County Kildare.

County Kildare Heritage Plan 2019-2025:

The second County Kildare Heritage Plan, covering the period 2019 - 2025, built upon the foundations laid by the original plan (2005 - 2018), and continued to guide heritage management and consultation in the county. This Plan reaffirmed a strategic approach to the protection and promotion of Kildare's heritage and identified actions aligned with its core objectives.

This draft Heritage Plan sets out to build upon the achievements of the previous Plan and identifies priorities for heritage in County Kildare over the next five years, taking account of changes at local, national and international levels since the publication of previous plans.

County Kildare Biodiversity Action Plan 2026-2031

Kildare County Council is preparing a new Local Authority Biodiversity Action Plan (LABAP).

Following the launch of the 4th National Biodiversity Action Plan in 2023, all Local Authorities are required to have a local Biodiversity Action Plans in place by the end of 2026.

This overlapping in the time period covered will allow for integrated and collaborative approach to protecting and enhancing biodiversity in County Kildare.

Kildare County Council Climate Action Plan 2024-2029

The KCC Climate Action Plan 2024 - 2029 replaces the previous Climate Adaptation Strategy and sets out a framework for both climate adaptation and mitigation across County Kildare. It aims to mainstream climate action into all functions of the local authority and supports the transition to a low-carbon, climate-resilient future. The Plan includes actions to address the impacts of climate change on built and natural heritage, ensuring that heritage is considered in planning, policy, and service delivery.

3. Guiding Principles

The overall objective of the County Kildare Heritage Plan is:

"To recognise by all, the value and opportunity of Kildare's unique heritage resource and to manage, conserve and protect it, in partnership, for present and future generations".

The County Kildare Heritage Plan 2026-2031 presents an opportunity to build on, and consolidate, the progress and achievements made through the implementation of the previous County Heritage Plans.

This draft plan seeks to continue this work with the wider community and various stakeholders to raise awareness, understanding and appreciation of Kildare's built, natural and cultural heritage assets. It represents a strategic approach to the management of heritage in Kildare. It is an opportunity to identify heritage issues and needs at a county level and to address them locally, within a regional and national framework underpinned by both national and local heritage policy.

The process for agreeing the plan is guided by the Heritage Act (1995), which includes as examples of heritage: monuments, archaeological objects, heritage objects, architectural heritage, flora, fauna, wildlife habitats, landscapes, geology, heritage gardens and parks and inland waterways. Additionally, the Kildare Heritage Plan makes provision for other aspects of cultural heritage such as history, genealogy, traditional skills and creative arts including local music, place names and folklore.

Factors underpinning this plan include

- local democracy
- customer service
- sustainability
- social inclusion
- community development
- efficiency and accountability

The County Kildare Heritage Forum is committed to an *integrated heritage approach* (built, cultural and natural) when implementing actions within the Heritage Plan. This will ensure that the benefits

for heritage are maximised from actions undertaken and that there is no net damage to Kildare's heritage resource. For example, actions with a strong archaeological focus will also be required to consider any potential benefits to or impacts on biodiversity or other heritage elements and vice versa.

The following principles were referred to throughout the process of preparing the Heritage Plan: Community- Through the implementation of the Heritage Plan, the Kildare Heritage Forum will endeavour to build the capacity of communities to engage and participate in heritage initiatives across the county.

Inter-generational Approach: The Heritage Forum will develop an intergenerational approach when delivering the projects and initiatives and seek to pass on to future generations the unique heritage knowledge and traditions of the county.

Working in Partnership - The Heritage Forum believes in the partnership model of working with the public/statutory, voluntary and private sectors.

Heritage as a Resource- In this plan heritage is seen as an intrinsic valuable resource in its own right. The Heritage Forum also considers that Kildare's heritage resource has a strategic economic potential that could be exploited with careful consideration of sustainable balanced development.

Irish Language - The Heritage Forum will endeavour to promote the Irish language as part of our unique Irish heritage and culture in the delivery of the plan.

To illustrate how these principles can be integrated into the actions arising from this plan, it is worth quoting from the Planning and Development Act 2024 which provides for a number of relevant strategies. Of particular note is the following:

A planning authority shall prepare a strategy for the creation, improvement and preservation of sustainable places and communities for the functional area of the planning authority.

1) The strategy shall include objectives for:

- a) the provision, improvement, extension and preservation of amenities, facilities and services to meet the social, community, recreational and cultural requirements of the functional area, including the needs of children, the elderly and persons with disabilities;
- b) the protection of the linguistic and cultural heritage, including the protection of Irish as the community language of any Gaeltacht in the functional area to which the development plan relates;
- the promotion of high standards (including high standards in public areas) of urban design, architecture and landscaping to enhance, improve and maintain the quality and character of urban and rural areas;
- d) the reservation of land use and cultivation as allotments and prescribed community gardens and the regulation, promotion, facilitation or control of the provision of land for that use;
- e) such other matters as may be prescribed.

As a development strategy framework, these measures will enable heritage issues to be dealt with as core principles of development.

The delivery of projects arising from proposals identified in the Heritage Plan will be subject to Appropriate Assessment Screening to determine the potential for likely significant effects on Natura 2000 sites.

4. Preparing the Heritage Plan 2026-2031

This Heritage Plan was prepared in accordance with the Heritage Council's *Guidelines for the Preparation of City/County Heritage Plan*. The membership of the Forum was renewed early in 2025 and set to work on the draft Plan. When required, additional relevant people with appropriate knowledge and expertise can be added to the Forum.

The public was invited at a series of five in person public information sessions and one online session to suggest issues that they would like to see addressed in the Heritage Plan. Submissions from the public were collated from the submissions portal into a submission report. A total of twenty two submissions were received. A number of broad themes and issues were identified. The Heritage Forum, having read all submissions, has had regard to the issues highlighted in these submissions and has used these as a basis of discussions which has resulted in the formulation of five strategic objectives with related actions in this draft County Kildare Heritage Plan (2026-2031).

The Heritage Forum acknowledges the many organisations, individuals and agencies already working to protect and enhance heritage within the county. The Heritage Plan seeks to expand on this work by concentrating on local heritage issues and seeks to further involve local communities in caring for their local heritage.

5. Appropriate Assessment and Strategic Environmental Assessment Screening

The Habitats Directive (Council Directive 92/43/EEC) as transposed into Irish law by the European Communities (Birds and Natural Habitats) Regulations 2011 requires that all plans and projects must be screened for potential significant effects on Natura 2000 sites (Special Areas of Conservation (SACs) and Special Protection Areas (SPAs)). Screening aims to establish whether a full Appropriate Assessment under Article 6 of the Directive is required.

Screening of the draft Heritage Plan 2026-2031 was undertaken in Autumn 2025 and the findings have informed the Plan as presented. Overall, it was concluded that the plan would have no significant adverse impacts on Natura 2000 sites and that no further assessment was necessary. Kildare Heritage Forum is committed to the implementation of the requirements of the Habitats Directive and an Appropriate Assessment Screening of the final draft of the Kildare Heritage Plan will be undertaken prior to its consideration and adoption by Kildare County Council. The screening of individual projects for appropriate assessment will also be undertaken where appropriate during the implementation of the Plan.

Strategic Environmental Assessment (SEA) is the formal, systematic evaluation of the likely significant environmental effects of implementing a plan or programme, or strategy, before a decision is made to adopt it. The SEA Directive requires that an SEA is undertaken for certain plans and programmes. Screening is the process for determining whether a particular plan, other than those for which SEA is mandatory, would be likely to have significant environmental effects, and would thus warrant SEA. Under the European Communities (Environmental Assessment of Certain Plans and Programmes) Regulations 2004 (SI No. 435 of 2004) amended by the European Communities (Environmental Assessment of Certain Plans and Programmes) (Amendment) Regulations 2011 (SI No. 200 of 2011), Kildare County Council is required to determine whether the draft plan needs to be subject to SEA.

6. Implementation of the Plan


The Heritage Plan is a strategic six-year work plan which will be implemented through the Heritage section's annual work programme, with input from the Heritage Forum and co-ordinated on a day to day basis by the Heritage Officer of Kildare County Council. While the Heritage Forum, Kildare County Council and the Heritage Council are key partners in the delivery and funding of the Plan, successful implementation of the Heritage Plan is dependent on the continued active engagement, support and participation of the wider community in Kildare including heritage groups, agencies, third level institutions and individuals. Opportunities to work in cooperation with partners within and outside the county for the delivery of the Plan will be availed of wherever possible. An annual work programme will be drafted based on the contents of the plan and current heritage priorities at local and national level. This will then be used to apply for funding to the Heritage Council and other sources. A mid-term report on the Heritage Plan actions undertaken and the progress made will be submitted to the members of Kildare County Council and published on the council's website.

Some events and organisations of note that contribute towards the objectives of the Plan include:

- National Heritage Week- a very popular national showcase event for heritage in the country.
 Now in it's twentieth year, Heritage Week encourages groups and individuals to raise the profile of their heritage interest, be it a much-loved local monument, or a traditional craft or conservation projects to support wildlife and habitats by holding an event during the week.
- Kildare Historic Monuments Advisory Committee. Kildare is one of only two counties
 nationally that have this committee in place. Provided for under National Monuments
 legislation, the Committee's role is to advise and support KCC in in looking after protected
 structures and sites in it's care.
- Other sections within Kildare County Council. Given that heritage covers a very wide range of issues, apart from the Heritage team directly and the wider Planning section of the council, many other sections contribute through their work to the objectives in the plan. This includes, Local Studies and Archives, the network of Kildare Libraries, the Parks section, Climate team and the Environment section as well as the five Municipal District offices

7. Funding

Kildare County Council is committed, in partnership with other agencies and organisations, to delivering this Heritage Plan, over the next six years, as resources permit. The Council will consider the funding allocation for the delivery of the Plan in accordance with the annual budget. The Council will also support the delivery of the Plan through the work of its Heritage Officer and other professional staff. Each year a detailed work programme is drawn up from the actions in this Plan, which will be submitted to the Heritage Council and other funding bodies as appropriate. The Heritage Council has agreed, in principle, to consider the Plan as a six-year strategic funding application. The Heritage Council will consider funding actions in the Plan, consistent with normal funding criteria, which are compatible with its objectives. Delivery of the Heritage Plan is facilitated by an annual funding allocation from the Heritage Council and co-funded by Kildare County Council. The commitment of other key partners to funding actions in the Plan will largely be dependent on their funding allocations and remits.

8. Monitoring and Evaluation

The Heritage Plan sets out a series of actions to be achieved over a six-year period. The annual work programme will detail the projects to be undertaken, and the partners responsible for their delivery. The Forum will monitor the annual work programme and will meet a minimum of four times annually to review and evaluate progress. In this regard, the Heritage Officer will report to Economic Development, Enterprise and Planning Strategic Policy Committee (S.P.C.). Working groups will be convened as needed for the purposes of achieving specific actions in the work programme.



9. Availability of Resources and Expertise

Specialist professional expertise will be sought where required and as resources permit, to implement the actions of the Heritage Plan. However, in order for the principles of heritage conservation and management to be fully integrated into the day to day operation of Kildare County Council, the appointment of full-time, suitably qualified additional staff in relevant areas, for example, community archaeology, would be desirable. The provision of staffing and other resources is an operational matter for Kildare County Council and is dependent on budget considerations.

It should also be noted the wealth of experience and expertise that exists in the network of groups and individuals concerned with heritage in the county and that these groups contribute significantly to the objectives of this and previous plans.

10. Strategic Heritage Objectives & Actions

The aim of the Heritage Plan is "to recognise the value and opportunity of Kildare's unique heritage resource and to manage, conserve and protect it, in partnership for present and future generations".
