

SECTION 75 ROADS ACT 1993 S.I. NO. 119/1994 ROADS REGULATIONS 1994 **NOTICE OF DECISION ROAD CLOSURE IN ACCORDANCE WITH SECTION 12(6) OF S.I. NO. 119/1994 ROADS REGULATIONS 1994** SHAMROCK SQUARE, CARLOW TOWN, CO CARLOW

Carlow County Council hereby gives notice of the decision to temporarily close roads and pedestrian crossings at Shamrock Square, Carlow Town. Following the issuance of a Dangerous Structure Notice on a building located at Shamrock Square, and in the interest of public safety, the following temporary traffic restrictions have been implemented as a precautionary measure while emergency works are being carried out:

- Right Turn lanes have been closed at Shamrock Square. No access to Upper Tullow Street at this junction when travelling from either Green lane or Staplestown Road and no access to Staplestown Road when travelling from Barrack Street. Diversions are in place.
- Traffic on Upper Tullow Street may only turn left or travel straight at the Junction of Shamrock Square and travel in the direction of Green Lane or Staplestown Road. No Right Turn onto Barrack Street. Diversions are in place.
- The Traffic lights are working and all road users should obey the traffic signals
- The pedestrian crossings on Staplestown Road and Green lane are closed. Please obey footpath closed signage and barriers. Pedestrian movement is only via Pedestrian crossing on Barrack Street and Upper Tullow Street. No pedestrians are permitted to access the fenced off area or enter the road carriage way.

The public is advised to follow all on-site signage and obey the traffic light signals.

MONASTEREVIN TO PORTARLINGTON GREENWAY - FEASIBILITY STUDY

Kildare County Council in co-operation with Laois County Council and Offaly County Council have undertaken a feasibility study to examine the potential for the development of a greenway between Monasterevin and Portarlington. Six potential routes have been identified. A baseline study has been completed examining;

- Population & Human Health
- Landscape Green & Blue Infrastructure
- Biodiversity
- Waterbodies, Soil & Geology
- Drainage, Structure & Traffic
- Air, Noise, Climate
- Built Heritage, Archaeology & Cultural Heritage
- Recreation & Tourism

We are now seeking input from the public on the potential options. While it is still at an early stage in the process, public opinions are welcomed on the emerging ideas.

The project is supported by the Department of Rural and Community Development's Outdoor Recreation Infrastructure Scheme (ORIS), which provides for the detailed development of projects with the objective of providing for new outdoor recreational infrastructure and/or, the enhancement of existing outdoor recreational infrastructure, to contribute to healthy active lifestyles. It also supports the economic and tourism potential of the area for both local communities and visitors alike.

The project is now at 'options' stage and Kildare County Council is seeking help in gathering further information and views from people who live, visit or work in or near Monasterevin and Portarlington, to help shape the project as it progresses towards the selection of a preferred option.
