EXTENSION OF TEMPORARY ROAD CLOSURE

NOTICE IS HEREBY GIVEN of the DECISION of Kildare County Council to EXTEND the duration of the closure as detailed below of the following road in accordance with Section 75 of the Roads Act, 1993 and the Roads Regulations, 1994:

No.	ROAD TO BE CLOSED	From (Junction with)	To (Junction with)
1	L-1004 (Dunfiirth Park Road)	L-5013 (Timahoe Road)	L-1008 (Knockanally)

From Saturday, 28 August 2021 to Friday, 29 October 2021.

The closure is required to facilitate installation of pipework.

Alternative Routes:

Eastbound vehicles travelling on the L-1004 (Dunfiirth Park Road) must divert right onto the L-5013 (Timahoe Road) at Dunfiirth Park crossroads (circa 6.04km) and then divert left at O'Brien Fine Foods and continue along the L-1017 (Donadea Road) (circa 5.28km). Vehicles will then divert left at Ballagh Woods crossroads onto the L-1008 (Newtownmoneenluggagh) (circa 4.08km) toward Knockanally.

Westbound vehicles travelling on the L-1008 (at Knockanally) must continue on the L-1008 (circa 4.08km) towards Ballagh Woods crossroads and turn right onto the L-1017 (Donadea Road) (circa 5.28km). Vehicles will then turn right onto the L-5013 (Timahoe Road) and travel towards Dunfiirth Park crossroads (circa 6.04km).

Diversions routes will be clearly signposted, as agreed with the Council and An Garda Síochána. Emergency access and restricted local access will be maintained. Any inconvenience caused is regretted.

Kildare County Council on behalf of Irish Water gives notice in accordance with Section 75 of the Roads Act, 1993 and the Roads Regulations, 1994 that it intends to close the following roads periodically during the period commencing Tuesday, 14 September 2021 through Monday, 27 September 2021 to facilitate water & wastewater connection works:

Alternative Routes:

- Vehicles wanting to travel eastbound on Moat Lane will be diverted south along Abbey Street (L-2996) and then directed to turn left onto Basin Street (L-2997). Vehicles will be directed to turn left again onto North Main Street (R-445) reaching the end of the diversion.
- Vehicles wanting to travel westbound on Town Hall Lane will be diverted south along North Main Street (R-445) and then directed to turn right onto Basin Street (L-2997). Vehicles will be directed to turn right again onto Abbey Street (L-2996) reaching the end of the diversion.

Diversions routes will be clearly signposted, as agreed with the Council and An Garda Síochána. Emergency access and restricted local access will be maintained.

Notice of proposal to make Road Traffic (Special Speed Limit) Bye Laws

Following requests to extend the Kildare County Council Speed Limit Review 2021, Kildare County Council has decided to extend the Public Consultation Period beyond the summer holiday period. Any submissions made in response to the notice published on Tuesday, 27 July 2021 remain valid and will inform the next stage of the process.

Kildare County Council, in exercise of the powers conferred on it by Section 9, subsection (4), of the Road Traffic Act, 2004 hereby gives notice of its proposal to make Special Speed Limit Bye-Laws in respect of public roads within the administrative area of the County of Kildare.
