PROPOSED CYCLE TRACK SCHEME AT CRADDOCKSTOWN ROAD, NAAS PLANNING REFERENCE: P82022.16

Pursuant to the requirements of the above, Kildare County Council proposes to provide a segregated high quality cycle track on Craddockstown Road, Naas.

The site is 350m in length and is located along the Craddockstown Road between the junction with Ballycane Road and the school campus on Craddockstown Road.

The Proposed Development comprises of:

- The provision of a 3m protected bi-directional cycle track on the north-eastern side of Craddockstown Road
- The provision of a 2m wide footpath on either side of Craddockstown Road
- Replacement of existing road crossing with Toucan crossing
- The improvement of side road crossing at Oak Glade

The new cycle track will link the existing two-way cycle infrastructure outside the school campus to the Ballycane Road junction on a segregated bi-directional cycle track.

The proposed scheme will also be available for inspection at Naas Library, Harbour View, Naas, W91 A997 (opening hours 10:00 a.m. – 5:00 p.m. Monday, Wednesday, Friday, Saturday, 10:00 a.m. – 8:00 p.m. Tuesday and Thursday).

The proposed development has undergone Appropriate Assessment Screening under the Habitats Directive (92/43/EEC) and the Planning and Development Act 2000, as amended and the Planning Authority has determined that a Stage 2 Appropriate Assessment is not required in this instance. In addition, the proposal has also undergone screening for Environmental Impact Assessment under the EIA Directive 2014/52/EU (and the relevant provisions of the Planning and Development Act 2000, as amended) and the Planning Authority has determined that there will be no real likelihood of significant effects on the environment arising from the proposed development and therefore an Environmental Impact Assessment is not required. In accordance with Section 120 of the Planning and Development Regulations (as amended), any person may, within 4 weeks from the date of this notice, apply to An Bord Pleanála for a screening determination as to whether the proposed development would be likely to have significant effects on the environment.

NOTICE TO FARMERS AND AGRICULTURAL CONTRACTORS

Kildare County Council advises all farmers and agricultural contractors of the requirements of the Good Agricultural Practice for the Protection of Water Regulations 2022.

Organic fertiliser or soiled water shall not be applied to land within:

- 5m of streams or drains
- 20m of lakeshores
- 25m of domestic wells
- 100-200m of Public water supplies

Organic and chemical fertilisers or soiled water shall not be applied to land in any of the following circumstances -

- the land is waterlogged;
- the land is flooded or likely to flood;
- the land is snow-covered or frozen;
- heavy rain is forecast within 48 hours, or
- the ground slopes steeply and there is a risk of water pollution having regard to factors such as surface runoff pathways, the presence of land drains, the absence of hedgerows to mitigate surface flow, soil condition and ground cover.

Adhering to the Regulations will help to improve Water Quality throughout the County.
