An Bord Pleanála has, on the 26<sup>th</sup> day of January 2024, made a confirmation order confirming (with modifications) the above-named compulsory purchase order as respects the land described in Part I and Part II of the Schedule hereto.

The said order, as so confirmed, authorises Kildare County Council to acquire the said land compulsorily. It will become operative three weeks from the date of publication of this notice.

The order also authorises the local authority to extinguish the public rights of way described in Part III of the Schedule hereto, by order made by them after they have acquired the said land.

An application for judicial review of the decision of the Board under Order 84 of the Rules of the Superior Courts (S.I. No. 15 of 1986) may be made to the High Court within eight weeks of the date of publication of this notice in
