## CARLOW COUNTY COUNCIL NOTICE OF CONSIDERATION OF A SCHEME FOR THE ABATEMENT OF RATES IN RESPECT OF VACANT PROPERTIES

Carlow County Council will consider a scheme providing for abatement of rates in respect of vacant properties, applying in the 2025 local financial year. Carlow County Council welcomes written submissions from the public on this matter specifically covering the potential effects of a scheme providing for the abatement of rates in respect of vacant properties on businesses, individuals and on local authority services.
