Ireland's first Age Friendly Estate has been launched at Castlefen Sallins.

Local TD and Minister for State at the Department of Transport and at the Department of the Environment, Climate and Communications, James Lawless and Kildare County Council cathaoirleach Joe

Neville attended the official ceremony on Friday September 6. The official launch marked the completion of works at Castlefen in a project supported by Kildare County Council, Kildare Age Friendly Alliance, Age Friendly Ireland and Castlefen Residents Association.

Castlefen is now considered a demonstrator

model for housing estates that want to adopt this process and be more prepared to support their ageing communities. AGI will showcase the work of Castlefen as a model of good practice nationally and internationally. The programme supports cities, counties and towns across Ireland to prepare for the rapid ageing of our

population by paying attention to the environmental, economic and social factors that influence the health and well-being of older adults. The programme provides walkable streets, housing and transportation options, access to key services and opportunities for older people to participate in community activities.

## PART 8 DEVELOPMENT

**Planning and Development Act 2000 (as amended) – Part XI

**Site Location: 1484 Castle Park, Kildangan,  
Co. Kildare, W34X008.**

**Proposed Development** In accordance with provisions of Part XI of the Planning and Development Act 2000, as amended and Part 8 of the Planning and Development Regulations 2001, as amended, notice is hereby given by Kildare County Council of a proposed development at this site at 1484 Castle Park, Kildangan, Co. Kildare, W34X008.

**The proposed works will comprise of:**

- a) a new single-story extension to the side and rear of the existing end of terrace bungalow.
- b) Alteration to front elevation by moving front door to new extension and all associated works.

The proposal has also undergone a preliminary examination under the EIA Directive 2011/92/EU as amended by Directive 2014/52/EU, (and the relevant provisions of the Planning and Development Act 2000, as amended, and the Planning and Development Regulations 2001, as amended) and the Planning Authority has concluded that there is no real likelihood of significant effects on the environment arising from the proposed development and that an Environmental Impact Assessment is not required.

Where any person considers that the proposed development would be likely to have significant effects on the environment, he or she may, at any time on or before **Thursday, 10 October, 2024**, apply in accordance with the provisions of article 120 of the Planning and Development Regulations 2001, as amended, to An Bord Pleanála for a screening determination as to whether the development would be likely to have such effects.

The proposed development has undergone Appropriate Assessment Screening under the Habitats Directive (92/43/EC) and the Planning and Development Act 2000, as amended and the Planning Authority has determined that a Natura Impact Statement is not required in this instance.

Plans and particulars of the proposed development (Part 8 Ref No. P82024.12) may be inspected or purchased at a fee not exceeding the reasonable cost of making a copy, at the **Public Display Area, Level 1, Kildare County Council, at the address below** on each day during which the said offices are open for the transaction of business (excluding Bank Holidays), during the period between **Thursday, 12 September, 2024 to Thursday, 10 October, 2024.**
