AS PREVIOUSLY MENTIONED IN MY LETTER OF THE 22<sup>ND</sup> SEPT 2017 TO THE MINISTER THESE SITES ARE SITUATED BESIDE THE EXISTING SETTLEMENT AREA AND DIRECTLY ADJACENT TO SERVICES ,SEWAGE, WATER, AND ELECTRICITY, IN OTHER WORDS THERE IS NO INTELLIGENT REASON WHY WE SEVEN CITIZENS INDIVIDUAL OWNERS OF THESE SITES FOR THE PAST 12 YEARS ARE NOT BEING ACCOMODATED.

THE MINISTER HAS THE POWER TO MAKE A JUSTIFIABLE DECISION TO INTERVENE AND TO DIRECT THE KILDARE PLANNING AUTHORITIES TO GIVE THE REQUIRED CONSIDERATION TO A JOINT APPLICATION FOR PLANNING IN THE INTEREST OF ACCOMODATING SEVEN IRISH SITE OWNING CITIZENS.



Dear Ms Reitz,

I refer to your correspondence regarding land zoning in the Kilteel area, Co. Kildare.

In the first instance, the zoning of land is a matter for the local authority, in this case Kildare County Council and I cannot comment directly on particular zoning matters outside of certain statutory process.

The main instruments for regulating and controlling physical planning within your area are the Kildare County Development Plan and relevant Local area Plans.

These Plans are adopted by the elected members of the Kildare County Council, following significant public consultation and consideration of relevant matters by the elected members. They do set out an overall strategy for the proper planning and sustainable development of the Kildare County area.

In this regard it is a local issue and therefore a matter for the relevant planning authority, i.e. Kildare County Council.
