As a lifelong resident of Caragh I would like to make the following submission to proposed CDP.

Community Gain.

Over the past 20 years over 300 houses and apartments have been built in Caragh Village. Other than the childrens playground, constructed on parish land, there was no community gain for the area of Caragh Village and environs. I enclose a copy of letter to KCC from Alan Dukes, dated 22 Feb. 2002 requesting an Area Action Plan.

Parish Field.

Planning Permission to develope Playing Pitches, walking track etc was granted, in 2005, ref 05/1053. The junior pitches for soccer and football were not developed. These pitches, centrally located and beside the primary school would be a huge advantage to the community. Caragh Celtic FC is currently renting pitches in Donore and face an uncertain future.

Affordable/Social Housing.

No affordable/social houses were constructed during the building of the estates in Caragh. Part 5 of the planning act was ignored. The site, close to railway, marked for development in proposed plan, was included in planning permission granted for Gingerstown Park. The construction of social/affordable houses included in grant of permission never happened. The site is still vacant, twenty years later. It is increasingly difficult for children of local families to get planning permission to build a one off home, the house prices in the village are prohibitive, circa €4/500,000. Support for young and old family members is critical for society so where will these young people live?

Flooding

The area marked on map as vulnerable to flooding is not accurate. In November 2000 the entire site under The Streams estate was flooded The site was then raised by infill of soil. This area was part of the Liffey flood plain and location of 2 Macrin drains. The macrin drain flowing through Castlekeely/Caragh joins the macrin drain from the bog close to the railway. The macrin drain from Castlekeely was piped through the site, for The Streams, to facilitate extra houses. OPW concerns were ignored. See attached copy of correspondence relating to this matter.

In conclusion I would like to state that the above comments should be read as constructive and not a criticism of the hard work that went into the production of the CDP.

Attention to above items would add to the quality of life for all residents, new and old.



Re: Culverting of stream at Caragh.
