Submission by Irene O'Neill, member of Kildare Branch of Inland Waterways Association of Ireland (IWAI)

Part 4 Resilient Economy & Job Creation

p38, **REO137**: Corbally Harbour: When the large silt build-up (i.e. the island) in the harbour is removed, this will make an ideal space for vessels large and small. It will also be a tourist destination for those boating, cycling and walking between Sallins and Corbally, and will be an ideal stop-over for refreshments when the Greenway extends further south to Newbridge. There are several business opportunities, such as hiring kayaks and canoes, barge trips between Naas and Corbally Harbours, providing refreshments, a place for boats and barges to stay awhile in the Kildare countryside.

p42, REP27: This objective is welcomed and supported.

p42, **REO154**: Users of the local waterways would undoubtedly like to work with KCC, Waterways Ireland, and local and touring boats in creating ways for berthing and in creating additional mooring locations.

As well as the Naas Harbour Quarter (described in Naas LAP), the economies of many other local areas would benefit from extra moorings; examples include Lullymore, Robertstown north of the canal, Rathangan on both sides of the bridge, Sallins extending to Soldier's Island, and both sides of Newbridge Road where it blocks the Corbally Canal.

p42, **RE O155** Circular Boating Route: The Green and Silver Route is 356km long with a total of 93 locks. It is a spectacular boating experience through urban and rural waterways commemorating an original journey made back in 1946. The engineering challenges faced by the builders of the Grand and Royal Canals over 220 years ago are striking; they built aqueducts, lifting and swivel bridges, single and double locks, and harbours; and they succeeded in creating canals through the bog.

Part 5 Sustainable Mobility & Transport

p17, TMO21. Said Grand Canal Greenway runs from Dublin to the River Shannon.

p31, TMO89: As a stalwart member of Kildare IWAI, I welcome the opportunity to work with KCC, Waterways Ireland and boat owners, to ensure any new crossings across the canals do not impede the passage of boats navigating the waterways.

Part 8 Urban Centres & Retail

p22, RETO27: This aspiration has my support.

p12: Kildare County Council is to be commended on its wish to re-generate old routes on water and land for recreation use; this being another way to encourage locals and visitors biking, boating and walking to explore the Kildare countryside and its attractions.

It is encouraging that KCC recognises the opportunities presented by the ceasing of commercial activities and the re-wetting of Bogs.

This is an opportunity to introduce eco-friendly living on canals.

p29 13.6.1. This is a very positive initiative, which is welcomed and supported.

p32 LRO39: I support the use of former commercial bogs as a way to provide healthy recreation for our citizens. Again, it is yet another way to encourage locals and visitors to go biking, boating and walking to explore the Kildare countryside and its attractions.

p32 LRO4: This area, whilst not in the immediate vicinity, is connected to the Barrow Line and, accordingly, has my support.

p33, **LRO50**. This is a welcome statement.

p33, LRO51 (a) Naas to Corbally Harbours and (b) Corbally Harbour to Newbridge.

As an active member of Kildare IWAI, I am involved in promoting the Branch's aspiration to extend the Grand Canal Greenway to Corbally Harbour, thus extending this recreational facility to the people of Newbridge, Kilcullen and Athgarvan.

p33, **LRO52**: Once again, as a member of Kildare IWAI, I am very supportive of the extension to Corbally Harbour with moorings, slipways, cafe and a service block. These would create an ideal tourist destination for those navigating Kildare Canals and encourage people to stay awhile and explore the amenities available to visitors in Kildare. It could also encourage local people to set up small businesses hiring kayaks and canoes, providing barge trips and refreshments.

p36, **LRA11**. Kildare County Council is to be commended on its wish to regenerate old routes on water and land for recreation use; this is yet another way to encourage locals and visitors biking, boating and walking to explore the Kildare countryside and its attractions.

The extension of the Grand Canal Greenway to Corbally Harbour would be welcomed.
