## Builder's Naas protest against KWETB

In last week's Leinster Leader (issue of March 1), we reported on builder Niall Healy's peaceful protest outside the Gael-Choláiste Chill Dara building on the Limerick Road in Naas.

Mr Healy, the managing director of NHC Construction Ltd, claims that KWETB owed him over €87,000 for works on the building.

Gael-Choláiste Chill Dara is located in the former St Patrick's

**Community College** building on the Limerick Road in Naas, and is under the patronage of An Foras Pátrúnachta. However, KWETB, under whose patronage St Patrick's operated, was responsible for contracting the works on the building.

In a subsequent statement to the Leinster Leader, a Gael-Choláiste Chill Dara representative emphasised: "It is important to note,

however, that Gael-Choláiste Chill Dara is an independent school under the patronage of An Foras Pátrúnachta and is only the current occupier of the building having been sited there by the Department of Education.

"The school has absolutely no links with KWETB, is not the contractee, is not a party regarding the payment process and indeed enjoys a positive relationship with the builder in

question."

KWETB said, "A dispute has arisen with a contractor in relation to works carried out at Gael-Choláiste Chill Dara. As both parties are not in agreement, in line with Section 15 of the Short **Public Works Contract** dealing with disputes, a suitably qualified conciliator is being appointed to work to support the resolution of the issue with both parties.'

Kildare gardaí have confirmed that €3,000 worth of cannabis was found in a car in **Dunmurray East on** Friday March 4.

According to a spokesperson, gardaí arrested three males (aged in their teens and 20s), who have all since been released without charge pending a file to the DPP; investigations are ongoing.

- Removal of material that has built up in the downstream riverbed
- Installing reflective flexible bollards.
