## **Pedestrians Cross South Main Street**

The members considered the following motion in the name of Councillor Clear

That the council extend the timings for pedestrians to cross on South Main Street at the

Bank of Ireland, as the time of 3-4 seconds is insufficient to make the crossing of the 9m

wide street; currently when the man flashes yellow, the yellow light for vehicles flashes too

which is causing a difficulty, particularly for children crossing and for elderly and disabled

pedestrians.

The motion was proposed by Councillor Clear, seconded by Councillor Brett

A report was received from the Roads, Transportation and Public Safety Department that the pedestrian crossing at the Bank of Ireland is a Pelican Crossing. In accordance with regulations / rules of the road the Green Man time (set at 7 seconds) is considered an invitation to cross the road, the time allowed to cross the road is a combination of the Flashing Green Man and Flashing Amber Man which is set at 10 seconds. Therefore, a pedestrian has potentially up to 17 seconds to cross the road (or a minimum of 10 seconds if they abide by the rules of the road) – the allocated crossing times are in accordance with current regulations and are considered sufficient at this location. It should be noted that the crossing times provided at this crossing are greater than the standard crossing times as recommended under relevant technical guidance documents. If the member has any technical queries in relation to traffic signal timing/sequencing etc. he is advised to contact Traffic Management Section staff at trafficlights@kildarecoco.ie and staff will assist to clarify any queries.

Councillor Clear made the following points

- The report was not accurate
- He checked the crossing and he still stated that pedestrians only have 3-4 seconds to cross the road.
- That is not enough time for the elderly or people with disabilities to cross
- That it is only in County Kildare that this is an issue
- Would like a meeting on site

The Municipal District Engineer advised the solution would be to narrow the crossing which could lead to congestion on the Main Street. He also advised he would get a printout of the report to show that the information is accurate.

The project is at Option Selection Stage and the emerging Preliminary Design will be shared with the municipal district members when an update on the schemes is presented later in 2022.

It is recommended that the provision of a crossing point at this location can be reviewed as part of any future comprehensive Sustainable Transport / Active Travel Schemes in the area.

The Vacant Homes Officer is investigating and liaising with the owners of privately owned vacant properties on Basin Street in an effort to bring these properties back into use.

A report was received by the Planning Department informing the members that 5 no. vacant sites have been identified within the Naas Municipal District. A Notice, in accordance with Section 7(1) of the Urban Regeneration and Housing Act 2015 (as amended), has been issued to the owners of these 5 sites. No further notice has issued, or levies have been collected to date.

Councillor Moore made the following points

- There are challenges and how do Kildare Co council get over these challenges?
- Is there a plan to progress getting the levies and not just sending out notices?

The Municipal District Manager advised that Kildare County Council had surveyed in excess of 100 sites during the implementation of the VSR and as few as 20 sites were considered appropriate for entry onto the register in the context of the legislative requirements set out under the relevant Act. A number of the sites entered on the register were also the subject of appeal to An Bord Pleanála. Of note is that the Government had recently introduced a new process for Land Activation (Residential Zoned Lands Tax) which will be collected by Revenue rather than the Local Authority.

The tender submissions have been accessed and we are currently progressing the post tender pre-qualification stage



following which the successful tenderer will be appointed. We hope to be in a position to appoint the successful design team in the coming weeks.

between the council and the developer of the shopping centre, as per Legal Agreement of
18/9/2008, which obliged the developer to either finance or construct same.

A report was received by the Roads and Planning department informing the members that the Kildare County Council Roads Planning Section has liaised with the Developer of the Naas Shopping Centre and their Technical Team, where we have confirmed that the road improvement works on Corbans Lane/ Friary Road as approved under the Part 8 will have to be constructed by the Developer. This will be subject to the design being agreed with the KCC Roads Planning Section and to the works being carried out within the CPO lands. These works will be Developer driven and KCC cannot confirm the timeline of these works.

The councillors made the following points

- There was a 999-year lease given and planning permission given in 2006 and still not developed yet
- People are constantly asking when will the shopping centre be open
- Can the developer be encouraged to get the development under way?
- Design for Corbans Lane is changing constantly, every 6 months.

As the Planning Authority was not notified of the details of the development at least two weeks prior to the commencement of works, as required under the legislation, the notification was deemed invalid and was returned.

Councillor Moore advised answer on report was not what he was focusing on, there were 4 buildings that have changed from a traditional shop front.

The Municipal District Engineer advised that they go out and look at them and update the members.

The members considered the following question in the name of Councillor Moore


Can the council identify if it has established a need for a further McAuley Place Retirement

Home in Naas based on its successful retirement environment facilities and its continuous

capacity filling?

A report was received from housing advising that Kildare County Council has a continuous need for 1 and 2 Bedroom units for accommodation of older people within the county. The Capital Assistance Scheme (CAS) provides funding to Approved Housing Bodies to provide special categories of accommodation including age friendly accommodation. CAS funding is provided by the Department of Housing, Local Government and Heritage and applications for funding are submitted directly to Kildare County Council. Currently there are 224 housing applicants aged 60 and over with a preference for Naas.

Kildare County Council engages with all AHBs who are active in the county regarding future housing provision, and this includes Nas Na Riogh who own and manage McAuley Place. The report was noted.

## Traffic calming project Sallins Village

The members considered the following question in the name of Councillor Breen Can the council update the members on the progress, success or otherwise on the traffic calming project in Sallins Village?

A report was received from Public Realm that the Sallins Traffic calming and Cycle Track scheme has been progressing well and is anticipated to be complete in July. The final items of work to be completed are the widened footpath in the town centre, including the associated modification to the pedestrian crossing signals, and provision of junction platforms including those at Hillview, Castlefen, Castlesize, Sallins Park, Canal Road, Osberstown Drive. The platforms are scheduled to be undertaken by a specialist road surfacing contractor during the third week of July.

The works in Sallins have been widely welcomed by residents and traders. This is the interim phase of the scheme and comments and observations on the scheme can be brought to the public consultation for the full scheme.

Councillor Breen asked if the bollards separating the cycle lanes from the traffic were temporary?

The meetings administrator informed the members that he would check this

The members considered the following question in the name of Councillor Clear Can members get an update on progress on the Grand Canal greenway from Sallins to Alymer Bridge?

A report was received from Public Realm that the Tender assessment is complete. Letters of regret and intent have been issued, standstill period has passed. Pre-Contract Award meeting to be held w/c 4th July with letter of Acceptance to issue soon after. A 12-month



construction programme is proposed with phasing to be discussed at pre contract award meeting.

## **Installation of CCTV**

The members considered the following motion in the name of Councillor Moore

That the council install CCTV in named 'black bag dumping' areas of Naas Town (*details provided*), in tandem with a survey of nearby residential units to establish evidenced based proof of legitimate disposal of domestic rubbish, now that offenders can be prosecuted using technology-based information.

The motion was proposed by Councillor Moore, seconded by Councillor Kenny

A report was received by Environment advising the members that as reported at previous Naas municipal district meetings, the council and our Community Wardens continue to work with the members and the local community in addressing incidents of illegal dumping. The members will be aware that we have used CCTV to monitor and enforce instances of littering and illegal dumping, including at known litter blackspots and at select bottle bank locations.

However, the processing of data through CCTV poses a risk to the rights and freedoms of individuals, and the council must have a legal basis for the processing of personal data through the use of CCTV.

The General Data Protection Regulations (GDPR) significantly increase the obligations and responsibilities for organisations and businesses in how they collect, use and protect personal data. Organisations are required to be fully transparent about how they are using and safeguarding personal data, and to be able to demonstrate accountability for their data processing activities.

Recognisable images captured by CCTV systems are "personal data" and are subject to the provisions of the Data Protection Acts.

The Circular Economy, Waste Management (Amendment) and Minerals Development (Amendment) Bill 2022 – currently before the Houses of the Oireachtas - makes provision for the use by local authorities of closed-circuit television and mobile recording devices in certain circumstances (e.g., deterring environmental pollution) and for that purpose to amend the Waste Management Act 1996 and the Litter Pollution Act 1997.

With regard to the second part of the motion, the council will carry out a survey of nearby properties as requested.

Councillor Moore thanked the Environment section for such an extensive report. He added that if CCTV can detect crime, it is his understanding that GDPR is not valid in this case. Councillor Moore wants assurance that the Environment section check with the 500 + people living in the area and check if they have sufficient ways of disposing their waste.

Ms A O'Malley stated a survey had already been given out to the residents, but the Environment department will carry out another survey.

Both sections on the motion to remain on the progress report.

**Resolved** on the proposal of Councillor Moore, seconded by Councillor Kenny and agreed by the members that the report be noted and for it to remain on the progress report.
