Item 15: The members considered the following motion in the name of Councillor Clear That the council provide a report on the traffic calming measures at Castle Farm Estate, Naas outlining why the four speed bumps were replaced with one chicane to reduce traffic speeds, despite being part of the original planning permission.

The motion was proposed by Councillor Clear, seconded by Councillor Brett.

A report was received from the Roads, Transportation and Public Safety Department that Kildare County Council Roads & Planning Section is satisfied that the Applicant/ Developer has complied with Condition 18 of Planning Reference 16-1145 below and that the chicanes have been designed, auto tracked, and installed to the proper standards. A Road Safety Audit Stage 2 was also carried out on the proposed design.

18. The Applicant shall remove the chicane opposite house units No.s 175/176. The Applicant shall provide opposing chicane adjacent to Unit No. 47. Details including width and surfacing of each chicane, shall be agree with Naas Area Office prior to commencement of development. The Applicant shall carry out a Road Safety Audit and auto tracking on proposed chicane design prior to commencement of development and all recommendations of RSA shall be incorporated into the design. The cost of the design and implementation of these works shall be borne solely by the Applicant.

Reason: In the interest of proper planning and traffic safety.

Kildare County Council Roads Planning Section has inspected the traffic calming arrangements within the Castle Farm Estate and are satisfied that there are currently adequate traffic calming measures within the estate to help reduce traffic speeding by motorist. Chicanes were preferred over speed ramps as part of the planning process where the design and location of the chicanes was agreed with the Kildare County Council Roads Planning Section. The use of horizontal deflection i.e., chicanes over vertical deflection i.e., speed ramps is recommended by the DMURS standards. The chicanes as installed require



motorists to stop/ slow down and to give way to oncoming traffic. It should be noted that there are several chicanes located throughout the estate. Speed ramps also generate noise and are a future maintenance issue.

Subject to this quotation being acceptable to Kildare County Council it is envisaged that these interim works could be undertaken within the coming two weeks.

A report was received from Corporate that the Aras Chill Dara was constructed with several energies saving measures in place such as:

- Reflexive lighting panels to maximise the lux level gained from lights.
- Natural ventilation system which reduces the need for Air Handling Units
- Automatic dimming systems which dim lights during the day while still maintaining correct Lux levels
- 36 solar panels for providing hot water

Since then, Facilities have continued along this path by:

- Installing a further 270 solar PV panels which provide approx. 70,000kw of electricity annually.
- Constant monitoring and servicing of all HVAC equipment
- Recently installed a new state of the art Light Management System to better monitor the use of lighting around the building.
- Currently installing a new Building Management System which will carefully monitor all aspects of the HVAC system.
