



NOTE: This draft map, prepared under Section 653C of the Taxes Consolidation Act 1997, has been published on Kildare County Council's website and is available for inspection at the offices.

This draft map has been prepared for the purposes of identifying land that shall be chargeable the relevant criteria and is to be subject to the residential zoned land tax. Residential properties, notwithstanding that they may be included on the draft map, shall not be chargeable to the residential zoned land tax.

Where the relevant criteria are met, the following are the relevant categories of land that:

- (a) is included in a development plan, in accordance with section 102(a) of the Act of 2000, or local area plan, in accordance with section 192(a) of the Act of 2000;
- (b) solely or primarily for residential use, or
- (c) for a mixture of uses, including residential use,

is reasonable to consider may have access to be connected, to public infrastructure and facilities, including roads and footpaths, public lighting, low sewer drainage, surface water drainage and water supply, necessary for dwellings to be developed and with sufficient service capacity available for such development, and

- (d) it is reasonable to consider is not affected, in terms of its physical condition, by matters to a sufficient extent to preclude the provision of dwellings, including
- (i) that is referred to in paragraph (a), and
- (ii) that is referred to in paragraph (b), and having regard only to development (within the meaning of the Act of 2000) which is not unauthorised development (within the meaning of the Act of 2000), or in use as premises, in which a trade or profession is being carried on, that is liable to commercial rates, that it is reasonable to consider is not suitable for residential use;
- (e) that is referred to in paragraph (a), unless it is reasonable to consider that the land is vacant or idle,

is reasonable to consider is required for, or is integral to, occupation by:

- (i) social, community or governmental infrastructure and facilities, including infrastructure and facilities used for the purposes of public administration or the provision of education or healthcare,
- (ii) transport facilities and infrastructure,

(II) energy infrastructure and facilities,

(IV) telecommunications infrastructure and facilities,

(V) water and wastewater infrastructure and facilities,

(VI) waste management and disposal infrastructure,

(VII) recreational infrastructure, including sports facilities and playgrounds,

(b) that is subject to a statutory designation that may preclude development, or

(c) (v) on which the derelict sites levy is payable in accordance with the Derelict Sites Act 1990.

Submissions on the draft map may be made in writing to the local authority concerned not later than 1 January 2023, regarding—

(i) the inclusion in or exclusion from the final map of specific sites, or

(ii) the data on which a site is classified the relevant criteria.

Submissions should include a name and address, reasons for inclusion or exclusion of lands, along with a map of scale 1:100,000 (urban area) or 1:250,000 (rural area) where the site is either the subject of a landowner, clearly identified on the land subject of the submission.

Any such written submissions received by 1 January 2023 other than such elements of a submission which may constitute public data, shall be published on Kildare County Council's website not later than 11 January 2023.

Where land identified on the draft map is included in a development plan or local area plan in accordance with section 102(x)(a) or 102(x)(a) of the Act of 2002 zoned—

(i) solely or primarily for residential use, or

(ii) for a mixture of uses, including residential use,

then any person who is not a person subject to the residential zoned land tax, a person may, in respect of land that such a person owns, make a submission to the local authority requesting a variation of the zoning of that land. Any such submission should include evidence of ownership, detailed reasons for any rezoning request, along with a map to a scale of 1:100,000 (urban) or 1:250,000 (rural) clearly identifying the relevant plot of land.

Any rezoning request made will be considered by the Local Authority and may be referred to the proper planning and sustainable development of the area.
