- Installation, upgrade, and retention of public lighting in line with recommendations from Bat Survey report; and
- Installation of shared path, drop kerbs, barriers and yield priority traffic management system in vicinity of Millennium Bridge under pass.

Holy Child National School, Safe Routes to School Scheme comprising of:

- Reconstruction and widening of footpath outside of the Holy Child National School on Lacken View, Naas to promote safe active travel.
- Installation of 4 no. uncontrolled pedestrian crossings along Lacken View and adjoining roads along Lacken View in close vicinity to the Holy Child National School.
- Installation of 1 no. controlled pedestrian crossings along Lacken View at the main entrance of the Holy Child National School.
- Installation of new pencil bollards along Lacken View.
- Traffic calming ramps installed at either side of the Holy Child National View along Lacken View and tightening of kerbing on adjoining T-Junctions to reduce vehicular speeds.
