To whom it may concern,

Kildare County Council has applied under Section 177AE (4) (a) of the Planning and Development Act (as amended) as inserted by Section 57 of the Planning and development (Amendment) Act 2010 to An Bord Pleanála for approval in relation to proposed rehabilitation works on Pass Bridge, a protected structure (Kildare County Council Record of Protected Structures Reference: B21-02 in Appendix 6 of the Kildare County Development Plan 2023-2029) which is located within the River Barrow and River Nore Special Area of Conservation (SAC). Kildare County Council has submitted a Natura Impact Statement (NIS) to An Bord Pleanála in respect of the proposed development.

Rehabilitation works arise from damage to the bridge by vehicle impact resulting in damage to the Parapet and the pier cutwater. Longitudinal cracking has been noted and secondary issues associated with bridge maintenance including damaged parapet, pavement remediation and vegetation removal.

The works will consist of

- Reconstruction of the cutwaters
- Repairs to the parapet
- Installation of rubbing strips
- Vegetation clearance
